BOARD OF SUPERVISORS MINUTES

May 11, 19 77

The Board of Supervisors convened in a special meeting for the purpose of a Public Hearing, as duly advertised, to consider the utilization of Federal Revenue Sharing Funds, with the following present: Supervisors Arliene Todd, William V. D. Johnson, W. P. Walker, Lloyd R. Kutter, and Thomas L. Stewart. Also present: John J. Fitzpatrick, Assistant to the Board; and Sally A. Traub, Deputy Clerk. Sixteen people were present in the audience.

Mr. John Fitzpatrick, Assistant to the Board, submitted the following requests for use of the Revenue Sharing Funds:

Thahmulla Mewuk Indian Council requested \$3,000.00 to record their language for educational purposes (in dictionary form), and that space be provided within the County for four employees or funds be made available to rent the needed space. Ms. Lee Garbani spoke on behalf of the Council and stressed the need for the money and space in order to record their language for history.

Mother Lode Rehabilitation Enterprises requested \$2,280.00 to be used as matching funds for grants from the State Department of Rehabilitation to generate approximately five times more spending power.

The Ad-Hoc Committee to Retain the Old County Office Center for Use by Community Service Organizations requested \$175,000.00 to renovate and restore the Porter Muffler Building in order to utilize the building for the benefit of all the people of El Dorado County.

Mr. Fitzpatrick then advised that the Revenue Sharing Funds had been proposed for use for construction of the new Superior Court Building at Placerville.

Ms. Diane Adcock, on behalf of the Commission on the Status of Women, requested one-half of the available funds for human services programs (i.e., Child Care Centers, Women Against Battering, Women Against Rape, and Child Abuse Prevention).

Ms. Kay King, on behalf of the Battered Women and the Rape Crisis Line, stressed the need for the human services programs.

Mr. Marlo Edman spoke in favor of renovating the Porter Muffler Building in order to house these proposed programs.

Ms. Linda Barbour was in support of the request to bring the Porter Muffler Building up to standards for the social programs.

Ms. Debbi Styles, Tenants Rising United, requested financial help for her organization.

Ms. Mary Allison suggested that a portion of the Porter Muffler Building, if renovated, could be used for over-the-counter food stamp sales.

Supervisor Stewart left the room.

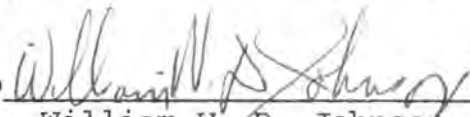
Miss Hazel Hoak submitted a proposal for use of Revenue Sharing Funds for the Child Care Centers.

No action was taken, and the meeting was adjourned to Tuesday, May 17, 1977, at 10:00 a.m.

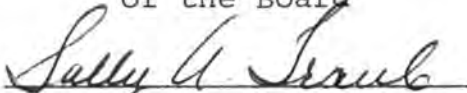
