OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

RESOLUTION APPROVING THE APPLICATION FOR GRANT FUNDS UNDER THE COMMUNITY PARKLANDS ACT OF 1986 AND THE WILDLIFE, COASTAL, AND PARKLAND CONSERVATION ACT OF 1988, for the following project:

Cameron Woods Community Park

WHEREAS, the people of the State of California have enacted the Community Parklands Act of 1986, and the Wildlife, Coastal, and Parkland Conservation Act of 1988, which provides funds to the State of California and its political subdivisions for acquiring and developing facilities for public recreational and historical purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing applications by local agencies under the program; and

WHEREAS, said applications contain assurances that the applicant must comply with; and

WHEREAS, the applicant agency will enter into an agreement with the State of California for acquisition, development, rehabilitation or restoration of the project;

WHEREAS, the County of El Dorado wishes to appoint the Cameron Park Community Services District as applicant for said funds.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors hereby:

1. Approve the filing of applications for Community Parklands Act of 1986 and the Wildlife, Coastal, and Parkland

Conservation Act of 1988, State grant assistance for the above project; and

2. Certifies that said agency understands the assurances and certification in the application form; and
3. Certifies that said agency has or will have sufficient funds to operate and maintain the project; and
4. Certifies that said agency will complete the project within three years from date of approval by the State; and
5. Appoint the Cameron Park Community Services District as agent of the County of El Dorado to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, payment requests, and so on, which may be necessary for the completion of the aforementioned project.
