



RESOLUTION NO. 031-2009

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO
AMENDING THE SALARY SCHEDULE OF EL DORADO COUNTY**

WHEREAS, the Board of Supervisors in adopting the budget for FY 2008/2009 has approved positions in new classifications; and

WHEREAS, it is necessary for the Board of Supervisors to approve the job specifications for the revised classification, and to adopt the salary range and designate the bargaining unit for this class; and

WHEREAS, the Information Technology Department has recruited, hired, assigned work, and reduced staff based on functional groups within the Information Technology Analyst Trainee/I/II classification since June 19, 1999; and

WHEREAS, the Human Resources Department has determined that creating separate classifications by functional groups in the classifications of Information Technology Analyst Trainee/I/II and Senior Information Technology Analyst would simplify recruiting, hiring, assignment of work and reductions in staff for the Information Technology Department; and

WHEREAS, upon approval of the Board, the establishment of the new classifications would result in the deletion of the Information Technology Analyst Trainee/I/II (JCN's 3156, 3151, 3152) and the Senior Information Technology Analyst (JCN 3154) classifications; and

WHEREAS, the County has advised the bargaining representatives of the proposed revised class specification, and the proposed salary range and bargaining unit as set forth below.

BE IT RESOLVED AND ORDERED that the Board of Supervisors of El Dorado County adopt the class specification for the revised classifications, and implement the designated bargaining unit as listed below and that this resolution shall, in accordance with Section 203 of the El Dorado County's Compensation Administration Resolution #227-84 for represented employees, and Section 601 of the Salary & Benefits Resolution #323-2001, as amended, for unrepresented employees, establish the salary range for the new classification to become effective the first full pay period following adoption of the Board of Supervisors; and

NOW, THEREFORE, BE IT FURTHER RESOLVED AND ORDERED that the El Dorado County Board of Supervisors amends the El Dorado County Salary Schedule as follows
