You must use one of the following options:

- **Drop off signed statement.** You may drop off your completed Signature Verification Statement at any Vote Center or Ballot Drop Box location for El Dorado County on or before 8:00 p.m. on Election Day, March 3, 2020.
- **Email signed statement to our office.** You may email your completed Signature Verification Statement to vbm@edcgov.us. It must be received no later than 5:00 p.m. on March 11, 2020.
- **Fax signed statement to our office.** You may fax your completed Signature Verification Statement to (530) 621-7480. It must be received no later than 5:00 p.m. on March 11, 2020.
- **Mail signed statement in the enclosed envelope to our office.** This Signature Verification Statement must be received at our office (address above) before 5:00 p.m. on March 11, 2020.. Postmarks will not count. If you choose to return your statement via mail, YOU MUST PLACE POSTAGE on the return envelope provided.
- **Come to our office in person.** You may come to our office (address above) Monday through Friday 8:00 a.m. to 5:00 p.m. and return your completed Signature Verification Statement. This must be done before 5:00 p.m. on March 11, 2020..
