**RE:** Renewal Application for Retired Probation CCW Authorization

This application is to request a “Carry a Concealed Weapon” approval as an honorably retired armed probation officer. I certify that I was, prior to retirement, an armed probation officer who during the course and scope of my employment as a peace officer was authorized to, and did, carry a firearm. I also certify that I qualified for and accepted a service or disability retirement; that my retirement is not because of a psychological disability, including stress disability; and that my retirement was not in lieu of termination or other discipline.

I accept and assume all responsibility and liability for, injury to, or death of any person or animal, or damage to any property which may result through any act or omission of either myself or the El Dorado County Probation Department. In the event any claim, suit or action is brought against El Dorado County, the El Dorado County Probation Department, the Chief Probation Officer or any employees, by reason of, or in connection with any such act or omission, I shall defend, indemnify, and hold harmless the agency that issued the endorsement for me to carry a concealed weapon, the Chief Probation Officer or any of its employees from such claim suit or action.

I authorize the El Dorado County Probation Department to investigate, as they deem necessary, my record and character to ascertain any and all information which may concern my qualifications and justification to be issued, maintain or renew an endorsement to carry a concealed weapon as an honorably retired probation officer, and release said agency of any and all liability arising out of such investigation.

I understand pursuant to U.S. Government Code – Title 49, Chapter 26, Section 1472(I) and Federal Aviation Regulation 121.583, a CCW endorsement to carry a concealed weapon does not authorize me to carry a firearm, tear gas, or any dangerous weapon aboard commercial airlines. Further, I must declare that I am carrying a firearm before entering the boarding area of an air terminal where security checks are made. Such violation can result in my arrest by law enforcement.

I have read, understood and agree to the above and hereby request to be issued a “CCW Approval” pursuant to PC §16690, 25450 et.al., and 26300 et.al. I have read, understood and agree to adhere to department policy F10 – Retired Armed Probation Officer, and understand this authorization, if granted, must be renewed every five (5) years, and it is my responsibility to initiate all required renewals. I also acknowledge it is my responsibility to comply with all legal requirements necessary to maintain my eligibility to be issued this “CCW Approval.”
