NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado, State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: Green Valley Road 2 Bridge Replacement Project (Indian Creek Bridge (25C0040) and Mound Springs Creek Bridge (25C0041)) CIP # 77127 (Green Valley Road at Indian Creek) and CIP # 77136 (Green Valley Road at Mound Springs Creek))

LOCATION: The Indian Creek Bridge (25C0040) and the Mound Springs Creek Bridge (25C0041) are located approximately 1,050 feet from each other along Green Valley Road just west of the City of Placerville in unincorporated El Dorado County.

APNs: 991-351-59 (County Road ROW), 317-287-02, 317-260-02, 317-260-09, 317-285-19, 317-285-01, 317-260-03, 317-260-25, 317-285-02, 317-250-30, 317-250-44, and 317-287-03

GENERAL DESCRIPTION: The El Dorado County, Department of Transportation intends to replace the two existing Green Valley Road bridges over Indian Creek (25C0040) and Mound Springs Creek (25C0041). The proposed wider bridges with a continuous median turn-lane in the roadway center will improve driver safety and be consistent with American Association of State Highway and Transportation Officials (AASHTO) guidelines.

Replacement of the structures is necessary due to: deficient hydraulics, poor site distance at adjacent roadways, substandard approach roadways and geometrics, as well as concrete spalling. The Project will adopt 2-stage construction so that Green Valley Road will remain open as much as possible during construction. A more detailed description can be found within Chapter 3 of the environmental document at the website below.

REVIEW: The review period for the Mitigated Negative Declaration begins on **February 2, 2018** and ends on **March 5, 2018**. The Mitigated Negative Declaration may be reviewed at County Transportation offices: 2850 Fairlane Court, Placerville, CA.
