NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE is hereby given that the County of El Dorado (County), State of California intends to adopt a Mitigated Negative Declaration for the project described below.

TITLE: Oflung Water Quality Project (County CIP #95177)

LOCATION: The Project area is located in eastern El Dorado County, within the Lake Tahoe Basin, south of South Lake Tahoe. The Project is bounded by Skyline Drive to the north, Elks Club Drive to the east, Pioneer Trail to the south, and Southern Pines Drive to the west. (Latitude 38.863780, Longitude -120.002181)

APN: County road right-of-way and APNs 081-092-009, 081-092-010, 081-111-012, 034-772-020, 034-761-008, 081-031-009, and 081-020-003.

GENERAL DESCRIPTION: El Dorado County Community Development Services, Department of Transportation, is proposing to: install erosion control and water quality improvements to reduce the discharge of sediment and pollutants to Lake Tahoe from County administered rights-of-way. The improvements will be to the existing storm water conveyance system which is comprised of channels, basins, culverts, inlets, asphalt concrete dikes, concrete curb & gutter, and infiltration systems.

REVIEW: The review period for the Mitigated Negative Declaration begins on November 30, 2018 and ends on December 31, 2018. The Mitigated Negative Declaration may be reviewed at the County Department of Transportation office at 924 B Emerald Bay Road, South Lake Tahoe, CA.
