The spec section 10-1.19 does reference freeway crossover in the same fashion as previous jobs in the same area but a full crossover detail is not shown. Please provide full detail for crossover.</p> <p>Answer: The bidder's attention is directed to the contract plans and specifications including but not necessarily limited to DE-5, DE-6, DED-1, SP 10-1.17 through and including SP 10 -1.31.</p>
