1.01	N-5	<p>Notice to Bidders –</p> <p>In the last sentence under “AWARD OF CONTRACT” add the word “responsive” after “lowest”.</p>
1.02	N-3, SP-23, C-6 and C-7	<p>Notice to Bidders, Section 5-1.22 of the Special Provisions, and Article 16 of the Agreement-“Prevailing Wage Requirements”</p> <p>Replace the first sentence of the first paragraph with <i>“In accordance with the provisions of California Labor Code Sections 1770 et seq, including but not limited to Sections 1773, 1773.1, 1773.2, 1773.6, and 1773.7, the general prevailing rate of wages in the county in which the Work is to be done has been determined by the Director of the California Department of Industrial Relations”.</i></p> <p>Delete the following sentence: <i>“This project is subject to the requirements of Title 8, Chapter 8, Subchapter 4.5 including the obligation to furnish certified payroll records directly to the Labor Commissioner in accordance with Section 16461. “</i></p>

1.03	SP-24	<p>Section 5-1.24 “Certified Payroll”</p> <p>Delete item 2d which reads as follows: <i>“d. Submit a copy of all payrolls weekly to the Engineer and directly to the Compliance Monitoring Unit (CMU) within the Division of Labor Standards Enforcement of the Department of Industrial Relations, State of California. Submit copy of all payrolls within 10 days of any separate request by the CMU.”</i></p>
1.04	SP-24	<p>Section 5-1.25 “Prevailing Wage Noticing Requirements”</p> <p>Delete this entire section.</p>
1.05	SP-14	<p>Section 5-1.07 “Interest on Payments”</p> <p>Replace item A with the following: <i>A. Unpaid progress payments, payment after acceptance, and final payments shall begin to accrue interest 30 days after the receipt of an undisputed and properly submitted pay request from the Contractor defined herein as the pay estimate prepared by the Engineer and approved by the Contract Administrator for the County.</i></p>


