**NOTICE TO BIDDERS**

**NOTICE IS HEREBY GIVEN** by the County of El Dorado, State of California, that sealed bids for work in accordance with the Project Plans (Plans) and Contract Documents designated:

**BRADFORD PARK RESTROOM SITEWORK AND INSTALLATION PROJECT**

**CONTRACT NO. PW 09-30437, CIP No. 97099**

will be received by Jean Warner at the Department of Transportation's Construction Division Office, 2441 Headington Road, Placerville, California, until **Monday, January 30, 2012 at 3:00 PM**, at which time bids will be publicly opened and read by the El Dorado County Department of Transportation, Construction Division.

No Bid may be withdrawn after the time established for receiving bids or before the award and execution of the Contract, unless the award is delayed for a period exceeding sixty (60) calendar days. Bids shall be executed in accordance with the instructions given and on the forms provided in the bound Contract Documents furnished by the El Dorado County, Department of Transportation. The proposal shall not be detached from the Contract Documents. All bids must be clearly marked on the envelope:

**LOCATION/DESCRIPTION OF THE WORK:** The project is located at Bradford Park, 4224 Motherlode Dr, Shingle Springs, California in El Dorado County. The Work to be done as shown on the Plans, generally consists of, but is not limited to:

The furnishing of all labor, materials and equipment required for the construction of a masonry bathroom including the interior and exterior fixtures (bathroom "kit" provided by the County), installation of wet and dry utilities to serve the bathroom, placing asphalt concrete and portland cement concrete for parking and walkways, grading, landscaping and parking lot striping.

- A. Bids are required for the entire work described herein.
- B. The contract time shall be ninety-two (92) CALENDAR DAYS.
- C. For bonding purposes the anticipated project cost is less than \$75,000.

**OBTAINING OR INSPECTING CONTRACT DOCUMENTS:** The Contract Documents and Plans may be examined at the El Dorado County Department of Transportation or may be obtained in person or by mail from the Department of Transportation, 2850 Fairlane Court, Placerville, California, 95667. The Contract Documents and ½ size Plans are available for pick-up at no charge. Full size plans can be purchased for twenty dollars (\$20.00) and is not refundable. To receive full size or half size plans by mail, send request stating which size plans are desired. The request must include an additional twenty dollars (\$20.00) for shipping and handling. (Full size plans by mail = \$40.00, Half size plans by mail = \$20.00) Full size plans will be provided to the successful bidder prior to construction. **Only Contract Documents obtained from the Department of Transportation will be acceptable for bid submittal.**

**PRE-BID CONFERENCE:** A mandatory pre-bid conference is scheduled to start 10:00 a.m. on **Friday, January 20, 2012**. The conference will begin at the DOT Corporation Yard, at 3671 Missouri Flat Rd, Placerville, California. This conference will allow bidders the opportunity to inspect the Bathroom Kit that the County is providing for this project. Immediately following the Bathroom Kit inspection, the bidders are required to continue the conference at the Bradford Park project site, located at 2442 Mother Lode Dr, Shingle Springs, California. Any questions that can be answered at that time by direct reference to the Contract and Plans will be answered. Questions which cannot be so answered may be addressed, if necessary, by addendum. Submission of a bid shall be considered an acknowledgment of familiarity with the Contract and Plans, and conditions of the County provided Bathroom Kit and at the Bradford Park project site.

**Attendance at the pre-bid conference is mandatory and only the bids of firms with representatives in attendance will be considered for evaluation and award. The Bidder's representative(s) will be required to sign an attendance sheet for each location and provide the name of the firm being represented.**

**CONTRACTORS LICENSE CLASSIFICATION:** Bidders shall be properly licensed to perform the Work pursuant to the Contractors' State License Law (Business and Professions Code Section 7000 et seq.) and shall possess a **Class B** license or equivalent combination of Classes required by the categories and type of Work included in the Contract Plans at the time bids are submitted, and shall maintain a valid license through completion and acceptance of the Work, including the guarantee and acceptance period. Failure of the successful Bidder to obtain proper adequate licensing shall constitute a failure to execute the Contract and shall result in the forfeiture of the Bidder's security.

**BUSINESS LICENSE:** The County Business License Ordinance provides that it is unlawful for any person to furnish supplies or services, or transact any kind of business in the unincorporated territory of El Dorado County without possessing a County business license unless exempt under County Ordinance Code Section 5.08.070. The Bidder to whom an award is made shall comply with all of the requirements of the County Business License Ordinance, where applicable, prior to beginning work under this Contract and at all times during the term of this Contract.

**REQUIRED LISTING OF PROPOSED SUBCONTRACTORS:** Each Proposal shall have listed therein the name and address of each subcontractor, to whom the Bidder proposes to subcontract portions of the work in an amount in excess of 1/2 of one percent of its total bid in accordance with the Subletting and Subcontracting Fair Practices Act, commencing with Section 4100 of the Public Contract Code. The Bidder shall also describe in the Subcontractor Listing the work to be performed by each subcontractor listed. The work to be performed by the subcontractor shall be shown by listing the description of the work, and portion of the work to be performed by the subcontractor in the form of a percentage calculated by dividing the work to be performed by the subcontractor by the lump sum bid price. At the time the bids are submitted all listed subcontractors shall be properly licensed to perform their designated portion of the work. The Bidder's attention is invited to other provisions of the Act related to the imposition of penalties for a failure to observe its provisions by using unauthorized subcontractors or by making unauthorized substitutions.

**PREVAILING WAGE REQUIREMENTS:** Contractor shall pay and require payment of wages according to a scale of prevailing wage rates determined by California law, which scale is on file at County's Department of Transportation, Facilities Engineering Division, and shall comply with all applicable wage requirements, as set forth in Labor Code Sections 1770 et seq., 1773.2, 1775, 1776, 1810 and 1813.

In accordance with the provisions of Labor Code Section 1810, eight (8) hours of labor shall constitute a legal day's work upon all work done hereunder, and Contractor and any subcontractor employed under this Contract shall also conform to and be bound by the provisions of Labor Code Sections 1810 through 1815.

**BID SECURITY:** A bid security shall be provided with each bid. Bid security shall be in an amount of not less than ten percent (10%) of the total amount bid for the Work and shall be cash, a certified check or cashier's check drawn to the order of the County of El Dorado or a Bidder's Bond executed by a surety satisfactory to the County of El Dorado on the **form provided in the Proposal section of these Contract Documents (do not detach the form).**

**AWARD OF CONTRACT:** Bids will be considered for award by the Director of the Department of Transportation. The County of El Dorado reserves the right after opening bids to reject any or all bids, to waive any irregularity in a bid, or to make award to the lowest responsive, responsible Bidder and reject all other bids, as it may best serve the interests of the County.

As a condition of award, the successful Bidder will be required to submit bonds and evidence of insurance prior to execution of the Agreement by the County. Failure to meet this requirement shall constitute abandonment of the Bid by the Bidder and forfeiture of the Bidder's security. Award will then be made to the next lowest responsible Bidder.

No oral responses to any questions concerning the content of the Plans and Contract Documents will be given.
