EDSWAC Meeting January 9, 2017 El Dorado County Staff Update

1. Grants

- a. Waste Tire Amnesty Grant: Events take place on the third Saturday of each month until the grant term ends (4/15/2017) or funds are exhausted (whichever occurs first). Collection of residential waste tires 24" inside tire diameter or smaller (off the rim).
 - I. EDD to date has collected 8,491 waste tires
 - II. STR to date has collected 592 waste tires
 - II. The next Waste Tire Amnesty Grant Cycle Application will be available soon. We plan to apply.
- b. Waste Tire Enforcement Grants (TEA): Inspection program to ensure facilities that have waste tires are in compliance with waste tire storage and hauling regulations.
 - II. TEA 23: Work Plan is complete. Progress report due in February.
 - III. TEA 24: Application submitted
- c. City County Payment Program: Enhance bottle/can recycling and litter abatement programs.
 - I. Trash/recycling bins for Main Street Placerville have been delivered to the City of Placerville.
 - II. Will be purchasing bear safe trash/recycling bins to be place in high priority locations in SLT. We've been working with Clean Tahoe to identify priority locations.
 - III. Will be purchasing a new Litter Abatement Program truck to replace one of our trucks that has many miles and is having mechanical issues.

2. Construction and Demolition

- a. Auditing Update:
 - I. EMD created master tracking list a way of analyzing and evaluating all C&D permits statuses and data
 - II. Conducting audits on a quarterly/monthly basis
 - III. Audit procedures for each Option (1, 2, 3, 4)
 - Option 1 audits evaluate if the permittee correctly used the assigned franchise waste hauler
 - Option 2 audits evaluate the amount of waste the permittee created compared to the set limits
 - Option 3 audits evaluate the Waste Management Plans (WMPs) throughout the project
 - o Option 4 is not currently being audited, but plans exist to audit them if needed

b. EDD is testing new C&D processing equipment:

- Grinder/shredder: Shreds all types of materials. Consolidates bulky materials which results in more efficiently packed trucks and reduced transportation.
- Shaker: separated 2D materials and fines from 3D/bulky items

4. Solid Waste Management Plan Update

- a. Environmentally Preferable Purchasing Policy Update:
 - I. Working with CAO's Office to identify credible environmentally preferable certifications that vendors and staff will know and be able to reference when preparing/reviewing quotes/bids. Next step: Meeting with CAO's Office.

b. Waste Characterization:

- I. In progress. Using data provided to CalRecycle by El Dorado Disposal in 2014 for the Statewide Waste Characterization Study conducted by Cascadia Consulting Group.

 II. EMD has requested to be informed when hauler perform waste audit so they can be present.
- c. Recycling Market Development Zone (RMDZ): RMDZ program combines recycling with economic development to fuel new businesses, expand existing ones, create jobs, and divert waste from landfills.
 - I. Nothing new to report. Continuing to work on application.

d. Office Recycling:

I. The county's white paper recycling contract with Motherlode Rehabilitation (MORE) has ended. Recycling carts are now in El Dorado County west slope main campus office buildings. The recycling carts collect mixed office recyclables (including white paper). This is a pilot program. Once any issues with the pilot program have been identified and resolved, recycling carts will be distributed throughout remaining west slope county offices. South Tahoe Refuse provides office recycling service to east slope county offices.




El Dorado Disposal Tonnage Report Trends for 2016 Quarters 1, 2, & 3


