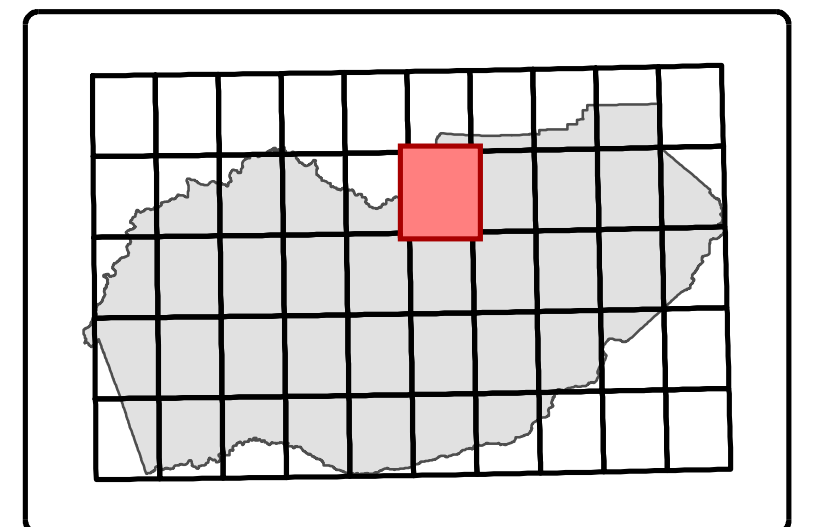
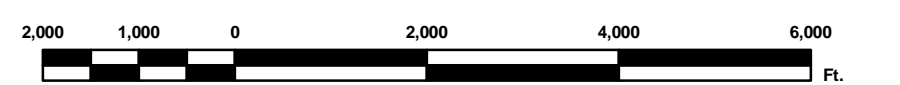
Land use data is developed and maintained by the El Dorado County Planning Department - GIS Division. This map uses a modified version of the parcel base referred to below.
