8. **SPECIAL USE PERMIT**

Special Use Permit Revision and Five-Year Cell Tower Review – S00-0025-R-2/Telecommunications Facility-Pinnacle Court submitted by METRO PCS CALIFORNIA, LLC for the following: 1. Revise a Special Use Permit to allow the replacement of four antennas with three and the addition of one equipment cabinet for Metro PCS; and 2. Request a five-year review of an existing cellular telecommunications facility. The property, identified by Assessor's Parcel Number 319-110-13, consisting of 5 acres, is located on the east side of Pinnacle Court, approximately 0.25 mile east of the intersection of Artesia and Shingle Springs Road, in the Shingle Springs area, Supervisorial District 4.
