If attendance is not possible, the project planner should be contacted prior to the hearing.

- a. **P06-0032 – GENE AND JOAN THORNE:** A tentative parcel map creating three (3) parcels ranging in size from 10 acres to 11.5 acres. Design waivers have been requested for the following: 1) Reduce the required on-site road width from 24 feet to 18 feet, with two-foot shoulders per State Responsibility Area Fire Safe Regulations; 2) Reduce the required off-site road width from the encroachment onto Jayhawk Drive to Deer Valley Road from 24 feet to 18 feet, without the two-foot shoulder improvements; 3) Request to make no road improvements to the portion of Jayhawk Drive along the northern property frontage of proposed Parcel 2. The property, identified by Assessor's Parcel Number **102-120-13**, consisting of 31.52 acres, is located on the south side of Jayhawk Drive, approximately 0.5 mile west of the intersection with Deer Valley Road in the Rescue area, Board of Supervisor District IV. (Negative declaration prepared)*
