**Project Location:** On the northwest side of Beau Val Lane approximately 500 feet northwest of the intersection with Pleasant Valley Road in the Pleasant Valley area, Supervisorial District II.

**Zoning:** Single Family Two-acre Residential (R2A)

**Environmental Setting:** The project site is served by the terminus of Beau Val Lane. The 30.14-acre site is located at the 2500 foot elevation above sea level. The entire parcel has been historically used for grazing and is devoid of groups of trees and shrubs except for around the dwellings, in the northwest corner, and along the intermittent stream near the entrance at Beau Val Lane and Pleasant Valley Road. Proposed Parcel 3 contains the existing primary single-family dwelling, barn, well, septic and driveway. Parcel 2 has a mobile home currently a second residential unit, a well, septic area and driveway. The highest point is within proposed Parcel 2 and the terrain slopes between 11 and 20 percent downward from there in all directions

**Description of Project:** The applicant requests approval of a tentative parcel map creating four parcels ranging in size from 5.05 to 10.055 acres on a 30.14-acre site. Road improvements include widening the existing on and off site access road, located in the 50-foot road and public utility easement, to El Dorado County Standard Plan 101-C, the cul-de-sac to Standard Plan 114, and the encroachment onto Pleasant Valley Road to Standard Plan 103-C. Individual wells and septic systems are proposed to be used for all four parcels.

**Discussion:** A substantial adverse effect to Visual Resources would result in the introduction of physical features that are not characteristic of the surrounding development, substantially change the natural landscape, or obstruct an identified public scenic vista.

- a. Scenic Vista. The project site and vicinity is not identified by the County as a scenic view or resource (El Dorado County Planning Services, El Dorado County General Plan Draft EIR (SCH #2001082030), May 2003, Exhibit 5.3-1 and Table 5.3-1). There would be no impact as a result of development of the proposed project.
- b. Scenic Resources. The project site is not within a State Scenic Highway. There are no trees or historic buildings that have been identified by the County as contributing to exceptional aesthetic value at the project site (California Department of Transportation, California Scenic Highway Program, Officially Designated State Scenic Highways, p.2 (<http://www.dot.ca.gov/hq/LandArch/scenic/schwy1.html>)).
- c. The creation of these four parcels would not directly change any views from what is currently available.
- d. The creation of these four parcels will allow new lighting by creating the potential for one primary and one additional second residential unit single-family dwelling on each parcel. These impacts would not be expected to be any more than any typical residential lighting similar and typical to those existing on the surrounding parcels and thus will have a less than significant impact on nighttime views in the area.

**Finding:** Any future development plan would require further review against the General Plan policies and any new potential project specific impacts would be analyzed at that time. The project and the potential introduction of new primary and secondary residential units, is compatible with the existing surrounding uses in the direct vicinity. For this “Aesthetics” category, there will be a less than significant impact.

**Discussion:** A substantial adverse effect to Agricultural Resources would occur if:

- There is a conversion of choice agricultural land to nonagricultural use, or impairment of the agricultural productivity of agricultural land;
  - The amount of agricultural land in the County is substantially reduced; or
  - Agricultural uses are subjected to impacts from adjacent incompatible land uses.
- a. The four proposed parcels are located on Josephine silt loam of 5 to 15 percent slopes (JtC) , and Josephine silt loam of 15 to 30 percent slopes (JtD) soils. Both are classified as unique, soils of local importance. Neither is classified as either prime farmland, statewide important farmland. Review of the General Plan land use map for the project area indicates that there are no areas of “Prime Farmland” or properties designated as being within the Agricultural District (A) General Plan land use overlay designation adjacent to or within the project site because the area the parcel is in was designated for Rural Center development instead by the 2004 General Plan. The project will not directly result in the conversion of farmland to non-agricultural uses as the five to 10-acre parcels are still large enough to do some type of non-commercial agricultural use.
- b & c. The creation of the four parcels will not conflict with existing zoning for agricultural use, and will not affect any properties under a Williamson Act Contract. No existing agricultural land will be converted to non-agricultural use as determined by the Rural Center designation and lack of an Agricultural overlay, as a result of the proposed project. There would be no impact.

**Finding:** No impacts to agricultural land would occur and no mitigation is required. For this “Agriculture” category, there will be a less than significant impact.

**Discussion:** A substantial adverse effect on Air Quality would occur if:

- Emissions of ROG and No<sub>x</sub> will result in construction or operation emissions greater than 82lbs/day (See Table 5.2, of the El Dorado County Air Pollution Control District – CEQA Guide);
  - Emissions of PM<sub>10</sub>, CO, SO<sub>2</sub> and No<sub>x</sub> as a result of construction or operation emissions, will result in ambient pollutant concentrations in excess of the applicable National or State Ambient Air Quality Standard (AAQS). Special standards for ozone, CO, and visibility apply in the Lake Tahoe Air Basin portion of the County; or
  - Emissions of toxic air contaminants cause cancer risk greater than 1 in 1 million (10 in 1 million if best available control technology for toxics is used) or a non-cancer Hazard Index greater than 1. In addition, the project must demonstrate compliance with all applicable District, State and U.S. EPA regulations governing toxic and hazardous emissions.
- a. The El Dorado County/California Clean Air Act Plan has set a schedule for implementing and funding Transportation Control Measures to limit mobile source emissions. The proposed project will not conflict with or obstruct the implementation of this plan.
- b & c. Currently, El Dorado County is classed as being in "severe non-attainment" status for Federal and State ambient air quality standards for ozone (O<sub>3</sub>). Additionally, the County is classified as being in "non-attainment" status for particulate matter (PM<sub>10</sub>) under the State's standards. The California Clean Air Act of 1988 requires the County's air pollution control program to meet the State's ambient air quality standards. The El Dorado County Air Pollution Control District (EDCAPCD) administers standard practices for stationary and point source air pollution control. Projected related air quality impacts are divided into two categories:

Short-term impacts related to construction activities; and  
Long-term impacts related to the project operation.

Short-term, superficial, minor grading and excavation activities that could be associated with the finish grading associated with future development permits and improvements to the existing roadway would be the only activities caused by the creation of these parcels as they could potentially have second residential units and accessory buildings, but that type of construction typically would only last a few days and intermittently at that.

Mobile emission sources such as automobiles, trucks, buses, and other internal combustion vehicles are responsible for more than 70 percent of the air pollution within the County, and more than one-half of California's air pollution. In addition to pollution generated by mobile emissions sources, additional vehicle emission pollutants are carried

into the western slope portion of El Dorado County from the greater Sacramento metropolitan area by prevailing winds. The four parcels are proposed to get access from Beau Val Lane. Future grading would potentially emit minor, temporary and intermittent criteria air pollutant emissions from vehicle exhaust and would be subject to El Dorado County Air Pollution Control District standards at that time. The proposed parcels are not located in an asbestos review area.

- d. Sensitive receptors include such groups as young children and the elderly and such sites as schools, hospitals, daycare centers, convalescent homes, and high concentrations of single-family residences. General Plan Policy 6.7.6.1 requires that the County ensure that new facilities in which sensitive receptors are located (e.g., schools, child care centers, playgrounds, retirement homes, and hospitals) are sited away from significant sources of air pollution. It has been determined that the proposed parcel sites are more than one mile from any sensitive receptors in the area, and any impacts from the project will be less than significant.
- e. The single-family residential uses allowed after the creation of these parcels do not, under normal circumstances, create any excessive objectionable odors.

**Finding:** A significant air quality impact is defined as any violation of an ambient air quality standard, any substantial contribution to an existing or projected air quality violation, or any exposure of sensitive receptors to substantial pollutant concentrations. As discussed above, no impacts on air quality would occur and no mitigation is required. For this “Air Quality” category, there will be a less than significant impact.

**Discussion:** A substantial adverse effect on Biological Resources would occur if the implementation of the project would:

- Substantially reduce or diminish habitat for native fish, wildlife or plants;
- Cause a fish or wildlife population to drop below self-sustaining levels;
- Threaten to eliminate a native plant or animal community;
- Reduce the number or restrict the range of a rare or endangered plant or animal;
- Substantially affect a rare or endangered species of animal or plant or the habitat of the species; or
- Interfere substantially with the movement of any resident or migratory fish or wildlife species.

- a – c. The creation of these parcels will not change the existing predominant open field habitat, nor the support for any of the special-status species of plants and wildlife known in the region. Further, the parcels do not fall within designated critical habitat or core areas for the Red-legged and Yellow-legged frog species. (El Dorado County Planning Services, El Dorado County General Plan Draft EIR (SCH #2001082030) May 2003, Exhibits 5.12-14, 5.12-5 and 5.12-7). None of the four parcels have either wetland land features or wetland indicator plants present on site. There is an intermittent drainageway offsite along about the first 300 feet of the east side of Beau Val Lane. The existing roadbed will have minor improvements which are not expected to create significant impacts. Best Management Practices required to be followed during the grading permit process will reduce the impacts to that stream to a less than significant level as the roadbed and ditches are existing and will need minor alterations to meet Department of Transportation 101C standards.
- d. Review of the Department of Fish and Game’s *Migratory Deer Herd Maps* indicate the project site does not lie within the range of a deer herd. Based on that fact, the proposed project would have a less than significant impact on deer migration patterns.
- e & f. The subject parcel is within the blue oak – foothill pine habitat types. (El Dorado County General Plan EIR, 5.12-7, May 2003). The parcel has been historically used for grazing and is devoid of groups of trees except those around the dwellings, the northwest corner and along 300 feet of the off site access road. The applicant submitted a *Tree Survey, Preservation and Replacement Plan* by EN2 Resources, dated June 25, 2007 that looked at the potential impacts to the existing oaks and made suggestions for replacement if major road repairs were done within the drip line of the oaks within the first 300 feet from the entrance off of Pleasant Valley Road. The potential road improvements off site will not involve the physical removal of native oak trees. The grading to improve the existing roadbed to meet County 101C standards will not be expected to have a significant impact on the existing line of oak trees along the intermittent stream or to the root systems of the existing oaks along the edge of it since the roadbed and drainage ditches have existed within the current location since at least 1983. The proposed road improvements are planned to be minor adjustments to the existing roadbed to widen the surface to 18 feet. This will not create significant impacts to the root zone and the required adherence to Best Management Practices by the grading permit requirements will cover potential erosion issues.

The project will not conflict with the provisions of any adopted or approved habitat conservation plan.

**Finding:** As discussed above, the impacts to biological resources will be less than significant.

**Discussion:** In general, significant impacts are those that diminish the integrity, research potential, or other characteristics that make a historical or cultural resource significant or important. A substantial adverse effect on Cultural Resources would occur if the implementation of the project would:

- Disrupt, alter, or adversely affect a prehistoric or historic archaeological site or a property or historic or cultural significant to a community or ethnic or social group; or a paleontological site except as a part of a scientific study;
- Affect a landmark of cultural/historical importance;
- Conflict with established recreational, educational, religious or scientific uses of the area; or
- Conflict with adopted environmental plans and goals of the community where it is located.

a-d An Cultural Resources Study was done on APN 078-270-12, (Historic Resource Associates, Dana Supernowitz, May 2007) which reported there were no significant prehistoric and historic-period cultural resources sites, artifacts, historic buildings, structures or objects found. Because of the possibility in the future that ground disturbances could turn up significant cultural resources anywhere in the County, the following condition will be added as a condition to address any potential future discovery:

“In the event of the discovery of human remains, all work is to stop and the County coroner shall be immediately notified pursuant to Section 7050.5 of the Health and Safety Code and Section 5097.98 of the Public Resources Code. If the remains are determined to be Native American, the Coroner must contact the Native American Heritage Commission within 24 hours. The treatment and disposition of human remains shall be completed consistent with guidelines of the Native American Heritage Commission. The Planning Services shall review the grading plans prior to the issuance of a grading permit, to ensure that this notation has been placed on the grading plans.”

**Finding:** Based upon the cultural resource study prepared for the site, it is determined that for this “Cultural Resources” category, the thresholds of significance would not be exceeded.

**Discussion:** A substantial adverse effect on Geologic Resources would occur if the implementation of the project would:

- Allow substantial development of structures or features in areas susceptible to seismically induced hazards such as groundshaking, liquefaction, seiche, and/or slope failure where the risk to people and property resulting from earthquakes could not be reduced through engineering and construction measures in accordance with regulations, codes, and professional standards;
  - Allow substantial development in areas subject to landslides, slope failure, erosion, subsidence, settlement, and/or expansive soils where the risk to people and property resulting from such geologic hazards could not be reduced through engineering and construction measures in accordance with regulations, codes, and professional standards; or

- a. There are no Earthquake Fault Zones subject to the Alquist-Priolo Earthquake Fault Zoning Act (formerly Special Studies Zone Act) in El Dorado County. No other active or potentially active faults have been mapped at or adjacent to the project site where near-field effects could occur. There would be no impact related to fault rupture. There are no known faults on the project site; however, the project site is located in a region of the Sierra Nevada foothills where numerous faults have been mapped. All other faults in the County, including those closest to the project site are considered inactive. (California Department of Conservation, California Geological Survey, Mineral Land Classification of El Dorado County, California, CGS Open-File Report 2000-03, 2001).

- b & c. **Soil Erosion and loss of topsoil.** All grading activities exceeding 50 cubic yards of graded material or grading completed for the purpose of supporting a structure must meet the provisions contained in the *County of El Dorado - Grading, Erosion, and Sediment Control Ordinance* Adopted by the County of El Dorado Board of Supervisors, 3-13-07 (Ordinance #4719). This ordinance is designed to limit erosion, control the loss of topsoil and sediment, limit surface runoff, and ensure stable soil and site conditions for the intended use in compliance with the El Dorado County General Plan. During any future site grading and construction of foundations and other site improvements, there is potential for erosion, changes in topography, and unstable soil conditions and that is addressed by grading permits.
- d. **Expansive soils** are those that greatly increase in volume when they absorb water and shrink when they dry out. The central half of the County has a moderate expansiveness rating while the eastern and western portions are rated low. These boundaries are very similar to those indicating erosion potential. When buildings are placed on expansive soils, foundations may rise each wet season and fall each dry season. This movement may result in cracking foundations, distortion of structures, and warping of doors and windows. Pursuant to the U.S.D.A. Soil Report for El Dorado County, the site is located on Josephine silt loam soil of 5 to 15 percent slopes (JtC) , and Josephine silt loam soil of 15 to 30 percent slopes (JtD) soils both of which have low shrink swell capacity. Table 18-1-B of the Uniform Building Code establishes a numerical expansion index for soil types ranging from very low to very high. Impacts would be less than significant.
- e. Two of the parcels already have approved septic systems for the primary single-family dwelling as well as the temporary mobile home. There would be a less than significant impact.

**Finding:** No significant geophysical impacts would occur from the parcel map request either directly or indirectly. For this “Geology and Soils” category, the thresholds of significance have not been exceeded.

**Discussion:** A substantial adverse effect due to Hazards or Hazardous Materials would occur if implementation of the project would:

- Expose people and property to hazards associated with the use, storage, transport, and disposal of hazardous materials where the risk of such exposure could not be reduced through implementation of Federal, State, and local laws and regulations;
  - Expose people and property to risks associated with wildland fires where such risks could not be reduced through implementation of proper fuel management techniques, buffers and landscape setbacks, structural design features, and emergency access; or

- h. **Fire Hazards.** The project site is in an area of very high hazard for wildland fire pursuant to Figure V.4-2 of the 1996 General Plan Draft EIR and Figure 5.8-4 of the 2004 General Plan Draft EIR. Compliance with the conditions required by the El Dorado County Fire Protection District, implementation of the required Fire Safe plan approved by the District, as well as California Building Codes, will reduce the impact of wildland fire on the project site to less than significant. **Discussion:** A substantial adverse effect on Hydrology and Water Quality would occur if the implementation of the project would:

- Expose residents to flood hazards by being located within the 100-year floodplain as defined by the Federal Emergency Management Agency;
  - Cause substantial change in the rate and amount of surface runoff leaving the project site ultimately causing a substantial change in the amount of water in a stream, river or other waterway;
  - Substantially interfere with groundwater recharge;
  - Cause degradation of water quality (temperature, dissolved oxygen, turbidity and/or other typical stormwater pollutants) in the project area; or

- a. **Water Quality Standards.** Wastewater is currently handled for the existing dwellings with two approved septic systems. Stormwater runoff from potential future development is required to be directed to an engineered drainage system and to contain water quality protection features in accordance with an NPDES stormwater permit if it is deemed applicable. These requirements will be further analyzed and then conditioned specific to the future development proposal. There would be no direct impact as the existing drainage patterns will not be significantly changed.
- b. **Groundwater.** Potable water is supplied by two existing private wells. El Dorado County lies within the Central Sierra Nevada geomorphic province. The geology of the Western Slope portion of El Dorado County is principally hard crystalline, igneous or metamorphic rock overlain with a thin mantle of sediment or soil. Groundwater in this region is found in fractures, joints, cracks, and fault zones within the bedrock mass. These discrete fracture areas are typically vertical in orientation rather than horizontal as in sedimentary or alluvial aquifers. Recharge is predominantly through rainfall infiltrating into the fractures. Movement of this groundwater is very limited due to the lack of porosity in the bedrock. There are 357 defined groundwater basins in California, but no designated basins are identified in El Dorado County. The El Dorado County Environmental Health Division has reviewed the current application requests had no concerns.
- c. **Erosion Control Plan.** The purpose of the erosion control program is to limit stormwater runoff and discharge from a site. The Regional Water Quality Control Board has established specific water quality objectives, and any project not meeting those objectives is required to apply for a Waste Discharge Permit. Compliance with an approved erosion control plan will reduce erosion and siltation on and off site. A grading permit through either Building Services or El Dorado County Department of Transportation would be required for any future development to address grading, erosion and sediment control. The potential permit required for the road improvements will be reviewed as well for compliance.
- d. **Existing Drainage Pattern.** The proposed project encompasses 30.14 acres. The rate of surface runoff from development will be minimized through the application review process; there would be a less than significant impact from the current proposal’s minor road improvements and future impervious surfaces created with development on the new parcels.
- e. **Stormwater Runoff.** There would insignificant impacts from stormwater runoff directly caused by the approval of this application request and minor road improvements.
- f. **Water Quality.** Wastewater and stormwater runoff from any future potential development would be analyzed further to assure water quality protection standards have been established. The parcel map request would not involve major physical changes to the environment. Impacts will be less than significant impact.

g, h and i. **Flooding.** No portion of the project is within the limits of the floodplain, as identified on the Flood Insurance Rate map. Therefore, no flooding impacts are expected.

j. **Inundation.** A seiche is a water wave within an enclosed body of water such as a lake or reservoir usually generated by an earthquake or landslide. A tsunami is a wave generated from earthquake activity on the ocean floor. The potential for a seiche or tsunami is considered less than significant because the project site is not located within the vicinity of a water body. A mudflow usually contains heterogeneous materials lubricated with large amounts of water often resulting from a dam failure or failure along an old stream course. There would be no potential impact from mudflow because the project site is not located within the vicinity of a dam or other water body.

**Finding:** Any future development plans submitted for a building and/or grading permit would be analyzed to address erosion and sediment control. No development plan accompanies this parcel map request. No significant hydrological impacts would occur with the project. For this “Hydrology” category, impacts will be less than significant.

**Discussion:** A substantial adverse effect on Land Use would occur if the implementation of the project would:

- Result in the conversion of Prime Farmland as defined by the State Department of Conservation;
- Result in conversion of land that either contains choice soils or which the County Agricultural Commission has identified as suitable for sustained grazing, provided that such lands were not assigned urban or other nonagricultural use in the Land Use Map;

This land use designation identifies those areas suitable for single-family residential development at densities of one dwelling unit per one to five acres. The creation of the four parcels would be compatible and appropriate within the MDR designated area.

**Discussion:** A substantial adverse effect due to Noise would occur if the implementation of the project would:

- Result in short-term construction noise that creates noise exposures to surrounding noise sensitive land uses in excess of 60dBA CNEL;
  - Result in long-term operational noise that creates noise exposures in excess of 60 dBA CNEL at the adjoining property line of a noise sensitive land use and the background noise level is increased by 3dBA, or more; or

The creation of the four parcels to accommodate single-family usage would not generate noise levels exceeding the performance standards contained in Tables 6-1 and 6-2 of the General Plan.
- b – d. Short-term noise impacts may be associated with excavation, grading, and construction activities in the parcel vicinity. El Dorado County requires that all construction vehicles and equipment, fixed or mobile, be equipped with properly maintained and functioning mufflers. All construction and grading operations are required to comply with the noise performance standards contained in the General Plan. The creation of the four parcels would require minor road improvements which would have a less than significant impact.
- e. General Plan Policy 6.5.2.1 requires that all projects, including single-family residential, within the 55 dB/CNEL contour of a County airport shall be evaluated against the noise guidelines and policies in the applicable Comprehensive Land Use Plan (CLUP). In this case, the project site is not located within the defined 55dB/CNEL noise contour of a County owned/operated airport facility.
- f. The proposed project is not located adjacent to or in the vicinity of a private airstrip. As such, the project will not be subjected to excessive noise from a private airport.

**Discussion:** A substantial adverse effect on Public Services would occur if the implementation of the project would:

- Substantially increase or expand the demand for fire protection and emergency medical services without increasing staffing and equipment to meet the Department’s/District’s goal of 1.5 firefighters per 1,000 residents and 2 firefighters per 1,000 residents, respectively;
- Substantially increase or expand the demand for public law enforcement protection without increasing staffing and equipment to maintain the Sheriff’s Department goal of one sworn officer per 1,000 residents;
- Substantially increase the public school student population exceeding current school capacity without also including provisions to adequately accommodate the increased demand in services;
- Place a demand for library services in excess of available resources;
- Substantially increase the local population without dedicating a minimum of 5 acres of developed parklands for every 1,000 residents; or
- Be inconsistent with County adopted goals, objectives or policies.

- a. **Fire Protection.** The El Dorado County Fire Protection District currently provides fire protection services to the project area. The District was solicited for comments to determine compliance with fire standards, El Dorado County General Plan, State Fire Safe Regulations as adopted by El Dorado County and the California Uniform Fire Code. The District did not respond with any concerns that the level of service would fall below the minimum requirements as a result of the proposed parcel map. The El Dorado County Fire Protection District has a satellite station adjoining the subject parcel. The impacts would be less than significant.
- b. **Police Protection.** The project site will be served by the El Dorado County Sheriff’s Department with a response time of 8 minutes to 80 percent of the population located in the Community Regions. For the rural areas, there is no standard minimum level of service or response time. Currently, the County has 0.89 sworn officers per 1,000 daytime populations. The project proposal would not significantly impact current response times to the project area. The impacts would be less than significant.
- c. **Schools.** The State allows school districts to directly levy fees on new residential and commercial/industrial development. These fees are collected at the time of building permit submittal and are designed to provide funds to acquire and construct additional facility space within impacted school districts. The project proposal would not directly generate the need for additional school facilities and will not impact school enrollment, as the project would not result in a dominant residential component. The impacts would be less than significant.
- d. **Parks.** Section 16.12.090 of County Code establishes the method to calculate the required amount of land for dedication for parkland, and an in-lieu fee amount for the subdivision of land. Provisions to provide parkland were not included as part of the proposal in accordance with Section 16.12.090 of County Code. The project proposal will not increase the demand for parkland. The impacts would be less than significant.
- e. **Other Facilities.** No other public facilities or services will be directly substantially impacted by the project. Any future potential impacts would be further analyzed in the in any future development application process. The impacts would be less than significant.

**Finding:** As discussed above, no significant impacts would occur with the project either directly or indirectly. For this “Public Services” category, impacts will be less than significant.

**Discussion:** A substantial adverse effect on Traffic would occur if the implementation of the project would:

- Result in an increase in traffic, which is substantial in relation to the existing traffic load and capacity of the street system;
  - Generate traffic volumes which cause violations of adopted level of service standards (project and cumulative); or
  - Result in, or worsen, Level of Service “F” traffic congestion during weekday, peak-hour periods on any highway, road, interchange or intersection in the unincorporated areas of the county as a result of a residential development project of 5 or more units.
- a – b. Access to the site is by way of Beau Val Lane directly off of Pleasant Valley Road for all proposed parcels which is County maintained. Comments were received from the El Dorado County Department of Transportation (DOT) indicating that the level of service (LOS) will not be significantly impacted by the proposed parcels which have an ultimate estimated traffic generation of ten Average Daily Trips (ADT) per parcel for a total of 40 ADT which does not worsen traffic pursuant to the General Plan definition of worsen. The impacts would be less than significant.
- c. The project will not result in a major change in established air traffic patterns as there are no publicly or privately operated airports or landing fields in the project vicinity.
- d. The project will not substantially increase hazards because the rough infrastructure for two residential units exist and any widening and resurfacing of Beau Val Lane as well as the implementation of a Fire District approved Fire Safe plan would improve safety conditions. The impacts would be less than significant.
- e. El Dorado County Fire Protection District will require an approved Fire Safe Plan to be recorded against the deed s of all four parcels with a Notice of Restriction and to be acted upon prior to issuance of the final approved parcel map, and in the future as well with the construction of any new structure. The impacts would be less than significant.
- f. The parking requirement for residential uses is two spaces per dwelling and all future residences shall be required to show two spaces of the Zoning Ordinance required size prior to issuance of a building permit. The impacts would be less than significant.
- g. The proposed parcel split does not conflict with the adopted General Plan policies, and adopted plans, or programs supporting alternative transportation. There will be no impact.

**Finding:** As discussed above, no significant traffic impacts would occur with the creation of these four parcels either directly or indirectly. For this “Transportation/Traffic” category, impacts will be less than significant.

**Discussion:** A substantial adverse effect on Utilities and Service Systems would occur if the implementation of the project would:

- Breach published national, state, or local standards relating to solid waste or litter control;
- Substantially increase the demand for potable water in excess of available supplies or distribution capacity without also including provisions to adequately accommodate the increased demand, or is unable to provide an adequate on-site water supply, including treatment, storage and distribution;
- Substantially increase the demand for the public collection, treatment, and disposal of wastewater without also including provisions to adequately accommodate the increased demand, or is unable to provide for adequate on-site wastewater system; or
- Result in demand for expansion of power or telecommunications service facilities without also including provisions to adequately accommodate the increased or expanded demand.

a, b & e **Wastewater.** The El Dorado County Environmental Health Division has reviewed the current application requests and determined the two existing septic systems are adequate and the submitted septic capability plan shows potential future adequacy potential for the newly proposed parcels. Impacts would be less than significant.

c. **Stormwater Drainage.** All required drainage facilities for the road/encroachment improvements will be fine tuned during the grading permit process required by El Dorado County Transportation Department. Initial review of the proposed plan determined that the current drainage patterns will not change in a major way. Other than that, the project proposal does not directly involve physical changes to the environment. Impacts would be less than significant.

d. **Potable Water.** Two of the parcels will contain existing approved wells with adequate production. El Dorado County Environmental Health Division is requiring that each parcel shall have a safe and reliable water source prior to recording the final map. The impacts would be less than significant.

f. **Landfill.** In December of 1996, direct public disposal into the Union Mine Disposal Site was discontinued and the Material Recovery Facility / Transfer Station was opened. Only certain inert waste materials (e.g., concrete, asphalt,

etc.) are allowed to be dumped at the Union Mine Waste Disposal site. All other waste materials that cannot be recycled are exported to the Lockwood Regional Landfill near Sparks, Nevada. In 1997, El Dorado County signed a 30-year contract with the Lockwood Landfill Facility for continued waste disposal services. The Lockwood Landfill has a remaining capacity of 43 million tons over the 655-acre site. Approximately six million tons of waste was deposited between 1979 and 1993. This equates to approximately 46,000 tons of waste per year for this period. This facility has more than sufficient capacity to serve the County for the next 30 years. There would be no impact.

- g. **Solid Waste.** County Ordinance No. 4319 requires that new development provide areas for adequate, accessible, and convenient storing, collecting, and loading of solid waste and recyclables. Solid waste pickup currently exists on a weekly basis for the subject parcel and would be expanded should a residential structure be constructed on the newly created parcel. There would be no impact.

**Finding:** No significant utility and service system impacts would occur with the subject applications. Any new development application would have the potential project specific impacts further analyzed at that time with a building or grading permit. For this “Utilities and Service Systems” category, impacts will be less than significant.

**Discussion:**

- a. As discussed in Item V (Cultural Resources), the proposed project would have no significant effect on historical or unique archaeological resources as all facilities exist. There would be no effects on fish habitat (Item IV). Potential impacts on rare or endangered plant species are discussed in detail in Item IV above, the Biological Resources section. As conditioned, there would be no significant effect on special-status plant or animal species as a result of the creation of these parcels alone.
- b. Due to the existing site specific conditions and type of project proposed and types of activities proposed, which have been disclosed in the Project Description and analyzed in Items I through XVI, there would be no significant impacts related to agriculture resources, air quality, geology/soils, hazards/hazardous materials, land use/planning, mineral resources, population/housing, public services, recreation, traffic that would combine with similar effects such that the project’s contribution would be cumulatively considerable.
